Sir,

In producing herewith one arrested accd. Person namely Uttam Ghosh (52 yrs) S/O- Lt Birbal Ghosh of Vill- Para Kayestho para, PS- Para, District - Purulia with seized articles (1) 20 (twenty) pcs sealed bottle of 80-up Country Spirit styled as 'DIL SE' each Bottle contains 600 ml and 2) 8 (Eight) pcs sealed bottle of 60-up Country Spirit styled as 'CAPTAIN' and Rs. 230/- as sale proceed.

I beg to submit that today (19/03/17) at 20:05 hrs acting on a source information I SI Sudhir kr Mahato along with my accompanied force held raid in hotel of Uttam Ghosh (52 yrs) S/O- Lt Birbal Ghosh of Vill- Para Kayestho para, PS- Para, District - Purulia against illegal stock and selling of liquor at the above noted anticipated place and found that the above noted person was keeping/selling Country Spirit which were kept in hotel. On demand he failed to produce any valid document in respect of selling of liquor from the hotel. As such I seized (1) 20 (twenty) pcs sealed bottle of 80-up Country Spirit styled as 'DIL SE' each Bottle contains 600 ml and 2) 8 (Eight) pcs sealed bottle of 60-up Country Spirit styled as 'CAPTAIN' and Rs. 230/- which is sale proceed as stated by the accused, under proper seizure list in presence of available witnesses from the exclusive possession of accd Uttam Ghosh and also arrested Uttam Ghosh (52 yrs) S/O- Lt Birbal Ghosh of Vill- Para Kayestho para, PS- Para, District - Purulia u/s 67 B.E.Act. During arrest inform the accd the ground of arrest and issued arrest memo..

The above noted arrested accd. namely Uttam Ghosh S/O- Lt Birbal Ghosh of Vill- Para Kayestho para, PS- Para, District - Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sale of country spirit from his hotel.

Under the above fact and circumstances I therefore pray that a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against accused Uttam Ghosh (52 yrs) S/O- Lt Birbal Ghosh of Vill- Para Kayestho para, PS- Para, District - Purulia and arrange for its investigation.
