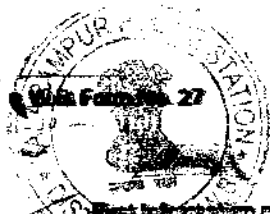

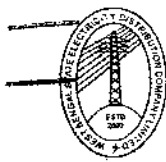

I Sri Amitava Choudhury, S/O Lt. Sajal Kr. Choudhury, A.E & Station Manager of Batarampur CCC of WBSEDCL do hereby lodge complaint against Sri Naren Singh Babu S/O Lt. Kalipada Singh Babu of vill- Kashidih, P.O. Nekre, P.S. Batarampur, Dist- Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his under construction building by way of direct hooking from the nearby LTOH line of WBSEDCL.

Acting upon such information today on 24/03/2017 in between 3.30 pm to 4.25 pm I along with Sri Anup Mandal, SAE (E), Sri Arindam Chatterjee, OE, Sri Shanti Pada Gosai, H.G. Sr L.M and contractor personnel of Batarampur CCC inspected the premises of Sri Naren Singh Babu and held raid.

During raid and inspection it was detected that accused Sri Naren Singh Babu is using the electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running one Centrifugal Monoblock pump set for watering the under construction building having connected load 0.75 KW/1 HP.

There was no scope to serve notice as the incident occurred in an open field, more over the premises ~~was~~ is under construction, without having electricity service connection.

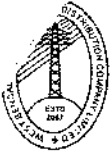

I prepared inspection report in presence of the witnesses and assessed the load as 0.75 KW. Details have been mentioned in the inspection sheet.

I directed Sri Shanti Pada Gorain, Hq Sr. LM to disconnect the hooking line from our LTOH line. Accordingly Sri Gorain disconnected the aforesaid hooking line from LTOH line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list. Local people witnessed the incident but refused to sign on the seizure list. A copy of the seizure list was handed over to the representative of the accused.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
