In producing herewith the accused person namely Gojen Mahato (40 yrs), S/O-Lt-Mathan Mahato of Vill-Bhurshu, P.S.-Baghmundi, Dist-Purulia along with seized Sir, articles 1) One tube loaded with ID liquor (Chullu) approx 30 ltr, 2) One tube loaded with ID liquor approx 20 ltr, 3) One plastic bottle loaded with ID liquor approx 1 ltr, 4) 4 (Four) piece plastic glass, 5. Cash Rs. 75/- (Seventy Five) which were seized under

I beg to submit that today on 08.03.17 during the special raid I along with 1. proper seizure list duly signed by the witness. C/370 Shyamapada Lohar, 2. C/513 Bhagirath Kuiry at 16:35 hrs arrived at Bhurshu village and a raid was conducted in the house of Gojen Mahato (40 yrs), S/O-Lt-Mathan Mahato of Vill-Bhurshu, P.S.-Baghmundi, Dist-Purulia, acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found the Gojen Mahato (40 yrs), S/O-Lt-Mathan Mahato of Vill-Bhurshu, P.S.-Baghmundi, Dist-Purulia were keeping/ selling Id Liquor (Chullu) which were kept with his possession in his house. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S- 67 B.E. Act. And also seized 1) One tube loaded with ID liquor approx 30 ltr, 2) One tube loaded with ID liquor approx 20 ltr, 3) One plastic bottle loaded with ID liquor approx 1 ltr, 4) 4 (Four) piece plastic glass, 5) Cash Rs. 75/- (Seventy Five) which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. A sample ID liquor (Chullu) taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the

The above noted arrested accused person namely, Gojen Mahato (40 yrs), S/O-Lt-Mathan Mahato of Vill-Bhurshu, P.S.-Baghmundi, Dist-Purulia committed an arrested person. offence U/S- 46 A(c) B.E. Act. 1909 for unauthorized possession and selling of Id

Liquor (Chullu) from his sole possession in his own house.

Under the fact and circumstances therefore pray a Case U/S- 46 A(c) B.E. Act. 1909 may kindly be started against the said accused person namely Gojen Mahato (40 yrs), S/O-Lt-Mathan Mahato of Vill-Bhurshu, P.S.-Baghmundi, Dist-Purulia.
