- 2) Sale proceed of Rs.- 95/-
- 3) Nine pieces of plastic glass.

I SI Supratik Mondal of Adra P.S. do here by lodged a complaint against accd. namely Ananda Mahato (55) S/O Lt. Dhanu Mahato of Vill- Kapista PS- Adra Dist- Purulia to the effect that today (06/03/17) at about 17:05 hrs in course of anti crime special mobile duty I received a telephonic information from a reliable source that one Ananda Mahato (55) S/O Lt. Dhanu Mahato of Vill- Kapista PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/219 Dasarat Hazari & JC/124 Avijit Khan rushed to the spot for raid by Govt. vehicle. At about 18:05 hrs. myself along with force reached at Kapista More under Adra PS and hold raid in the Goomty of Ananda Mahato (55) S/O Lt. Dhanu Mahato found that said Ananda Mahato liquor at his own Goomty and seeing the police party some person fled away and said Ananda Mahato to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Ananda Mahato (55) S/O Lt. Dhanu Mahato of Vill- Kapista PS- Adra Dist- Purulia and arrange for its investigation.
