I ASI Somnath Mahanty of Adra Police Station in producing herewith accused Samrat Ghoshal S/O Dilip Ghoshal of Adra Main Post Office Para PS- Adra Dist- Purulia under arrest and also the seized articles under proper seizure list one 7.65 mm bore Pistol (improvised fire arms) measuring total length 26 cm (approx), barrel length 9.5 cm (approx), body length 5.5 cm (approx) and butt length 11 cm (approx) having barrel, trigger, trigger guard, firing pin, hammer, slide ( it is written on the slide of the arms "AUTOMATIC PISTAL MADE IN USA NO 701 ", "AUTO PISTOL 7.65 7 ROUND", "ONLY FOR ARMY SUPPLY" ) in working condition loaded with 02 round 7.65 mm KF live ammunition in a magazine (under proper seizure list) do hereby lodged complaint against Samrat Ghoshal S/O Dilip Ghoshal of Adra Main Post Office Para PS- Adra Dist- Purulia to the effect that on 06.03.2017 at 22:45 hrs, In course of our night mobile patrol duty myself along with C/726 Dipankar Mahato and C/ 1052 Shyamlal Murmu all are of Adra Police Station, after receiving a secrete source information I held raid at Bilmoria More which is situated near Adra Railway Station and found that the above noted person was moving suspiciously. I asked his name and address , he disclosed his name and address as noted above. I searched him and found One 7.65 mm Pistol loaded with two round live ammunition from his exclusive possession kept on his left waist under the support of his wearing full pant. I asked him to produce valid document in respect of possessing of fire arms and ammuaitions but he could not produce any valid document in respect of possession of fire arms and can't give any satisfactory answer of procurement of fire arms. I seized the above noted fire arms and live ammunition under proper seizure list and also arrested above noted accused. I interrogated the above noted arrested accused person. On further interrogation he clearly stated that he was released on bail from Raghunathpur SD Correctional Home in c/w theft case.

Under the above circumstances, it is evident that the above noted accused person violated the purview of arms act for possessing of illegal fire arms.

Therefore, I pray to you that a specific case may kindly be started under proper section of law against the aforesaid accused person.
