Sub:-Prayer for starting a specific case against namely Joydev Gorai (29), s/o-Khagen Gorai of vill-Torang, PS-Arsha, Dist-Purulia

Sir,

In producing herewith one accused person namely Joydev Gorai(29),s/o-Khagen Gorai of vill-Torang, PS Arsha, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Twenty five (25) sealed bottles (CS) containing 600 ml each and labeled with DILSE.
- 2) Eighteen (18) sealed plastic bottles (CS) containing 375 ml each and labeled with DIL KHUSH.
- 3) Cash Rs 455/- (Four hundred fifty five only).
- 4) One yellow nylon bag.
- 5) One white big polythin bag.

I do hereby lodge this complaint regarding that today 08.02.17 at about 16.45 hrs during my evening mobile duty received source information over telephone that the above noted accused has been selling liquor illegally and clandestinely in front of his grocery shop at Torang village under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/both of SAP 7<sup>th</sup> Bn camp at Arsha PS rushed to the spot to work out the information. On arriving to the spot I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Joydev Gorai (29), s/o-Khagen Gorai of vill-Torang, PS-Arsha, Dist-Purulia after preparing proper memo of arrest.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
