On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/both of SAP 7th Bn camp at Arsha P5 rushed to the spot to work out the information. Accordingly I seized all those noted above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Joydev Gorai (29), s/o-Khagen Gorai of vill-Torang, PS-Arsha, Dist-Purulia after preparing proper memo of arrest.
