In producing herewith the accused person namely Mrityunjoy Kuiry (40 yrs), Sir. S/O-Purna Ch. Kuiry of Vill-Gagi, P.S.-Baghmundi, Dist-Purulia along with seized articles 1) 30 ltr ID liquor (Chullu) in a Jeri can, 2) 06 (Six) bottle ID liqure containing 600 ml ltr "Dil Khush", 3) Sale proceed Rs. 85 rupees (Eighty Five), which

were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 10.03.17 during the special raid I along with 1. C/411 Ragda Mandi, 2. C/94 Ratan Kr. Bhoumik, 3. C/425 Karam Ch Saren al, of Baghmundi P.S at 14:45 hrs arrived at Gagi village and a raid was conducted in the house of Mrityunjoy Kuiry (40 yrs), S/O-Purna Ch. Kuiry of Vill-Gagi, P.S.-Baghmundi, Dist-Purulia, acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found the Mrityunjoy Kuiry (40 yrs), S/O-Purna Ch. Kuiry of Vill-Gagi, P.S.-Baghmundi, Dist-Purulia were keeping/ selling Id Liquor (Chullu) and country made "Dil Se" which were kept with his possession in his house. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S-67 B.E. Act. And also seized 1) 30 ltr ID liquor (Chullu) in a Jeri can, 2) 06 (Six) bottle ID liqure containing 600 ml ltr "Dil Khush", 3) Sale proceed Rs. 85 rupees (Eighty Five), which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. A sample ID liquor (Chullu) taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person. During arrest the ground of arrest was duly notified, issued arrest memo U/S-50 Cr.P.C and handed over a copy of the same to the arrested person.

The above noted arrested accused person namely, Mrityunjoy Kuiry (40 yrs), S/O-Purna Ch. Kuiry of Vill-Gagi, P.S.-Baghmundi, Dist-Purulia committed an offence U/S- 46 A(c) B.E. Act. 1909 for unauthorized possession and selling of Id Liquor (Chullu) and country made ID liquor from his sole possession in his own house.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and obliged.
