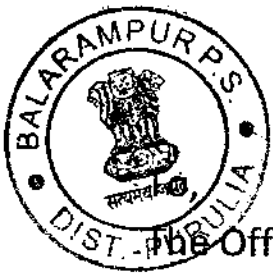

Sub: Complaint against Chandan Saw S/O- Thakur Saw of Vill.- Balarampur Tata Road, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46 A(C) B.E. Act.

Respected Sir,

In producing here with one arrested accused person namely Chandan Saw S/O- Thakur Saw of Vill.- Balarampur Tata Road P.S.- Balarampur, Dist. Purulia along with seized 17 (seventeen) sealed country sprit bottles (DIL SE) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 19.55 hrs I received a credible source information that one person namely Chandan Saw S/O- Thakur Saw of Vill.- Balarampur Tata Road P.S.- Balarampur, Dist. Purulia is carrying country sprit without any valid license at Namsole more area under Balarampur P.S., Dist.- Purulia. Accordingly, I along with force left for Namsole more to work out the source information and held raid at Namsole more.

During search with the help of accompany force, we found that the said person is carrying country sprit bottles for sale. On demand, he failed to produce any valid documents/ License in respect of carrying and keeping of said country sprit. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46 A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 17(seventeen) sealed country sprit bottles has been seized, total value of the said seized Country sprit is Rs- 510/= (Five hundred & ten only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Chandan Saw S/O- Thakur Saw of Vill.- Balarampur Tata Road P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
