Sir,

In producing here with the arrested accused Kundan Lal Rajak @ Lelu (29 yrs) S/O- Lt. Nandulal Rajak of Majhidih, PS- Adra, Dist- Purulia and one seized improvised country made pipe gun having 9 1/2 inch length from butt to barrel and length of barrel approx 6 1/2 inch, Length of Body 3 inch, length of butt approx 2 inch 10 cm having trigger, firing pin along with two (02) round live ammunition before you.

The fact of the case in brief is that today i.e on 09.04.2017 myself along with C/1478 Dhirendranath Mahato, C/1055 Santimoy Samanta were performing evening mobile duty at Dubra side area. During evening mobile duty at 20:10 hrs received credible source information that one person is coming from Raghunathpur side towards Dubra side and one improvised fire arm is with him. I informed the matter to O/C Para PS and as per order I rushed towards Rukni side to work out the information. Myself along with force reached near Rukni morh and hid ourselves in the dark of night. After few minutes at 20:55 hrs found that one person is coming from Raghunathpur side. When he reached near Rukni morh we came out from the dark and seeing the Police party he started to run. But after a hot chase we able to intercept him at Rukni morh. On search found that he possessed one improvised country made pipe gun at left side of his waist in which 01 (one) rd live ammunition was fitted and in right side pocket of his pant there is 01 (one) rd live ammunition. On asked he disclosed his identity as Kundan Lal Rajak @ Lelu (29 yrs) S/O Lt. Nandulal Rajak of Majhidih, PS Adra, Dist- Purulia and he could not able to produce any license or valid document in respect of possessing and carrying of that improvised fire arm. Finding no other alternative I arrested him after informing him the ground of arrest and after observing all legal formalities and also seized the improvised country made pipe gun having 9 1/2 inch length from butt to barrel and Length of barrel approx 6 1/2 inch, Length of Body 3 inch, length of butt approx 2 inch 10 cm having trigger, firing pin and 02 (Two) rd live ammunition from the exclusive possession of the arrested accused person Kundan Lal Rajak @ Lelu under proper seizure list in presence of witnesses duly signed by them.

Under the above circumstances I pray before you for starting a case under proper section of law against accused Kundan Lal Rajak @ Lelu S/O- Lt. Nandulal Rajak of Majhidih, PS- Adra, Dist- Purulia for possessing and carrying of improvised country made fire arms and arrange for its investigation.
