information that the aforesaid accused person is committing theft of electricity
in his residence by way of direct hooking from the nearby LTOH line of
WBSEDCL.

Acting upon such information today on 10/04/2017 in between 1:00 pm to
1:30 pm I along with Sri Jitendra Bahaman Mondal, A-E of S&LP Unit Purnia
Region, Sri Samar Kr. Pandey (Retd DSP), S.O., Purnia Region, Sri Anup Mandal
SAE, Bakarampur CCC, Sri Dhajadhari Sarkar, ACM Bakarampur CCC and
other officials of WBSEDCL inspected the premises of Laxman Kumar (Majhi)
and held raid.

During raid and inspection it was detected that accused Sri Laxman Kumar
(Majhi) is using the electricity dishonestly by making direct hooking from the
nearby LTOH line of WBSEDCL for using the following electrical equipments.

No notice was served to the accused as he is not a consumer and the premises have no electricity service connection.

I directed Sri Dhajadhari Sarkar, ACM to disconnect the hooking line from our LTOH line. Accordingly Sri Sarkar disconnected the aforesaid hooking line from LTOH line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list. Local people who witnessed the incident refused to sign on the seizure list. The accused also refused to sign on seizure list.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence 135(i) (a) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
