In producing here with one arrested accd namely Bimal Bouri (41 Yrs.) S/O Shital Bouri of Vill- Metyal Sahar PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 21 bottles (in sealed condition) DIL KHUSH 80 up country spirit, 600-ml each bottle and value-Rs-30 of each bottle.
- 2) Sale proceed of Rs.- 103/-
- 3) Eleven pieces of plastic glass.

I SI Supratik Mondal of Adra P.S. do here by lodged a complaint against accd. namely Bimal Bouri (41 Yrs.) S/O Shital Bouri of Vill- Metyal Sahar PS- Adra Dist- Purulia to the effect that today (10/03/17) at about 14:25 hrs. I received a telephonic information from a reliable source that one Metyal Sahar Village PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/ 572 Ajoy Giri & JC/124 Avijit Khan rushed to the spot for raid by Govt. vehicle vide Adra PS GDE No. 446 Dt. 10.03.17. At about 15:30 hrs. Myself along with force reached at Metyal Sahar Village under Adra PS and hold raid in the Goomty at Metyal Sahar Village (Near Rly. Station) of Bimal Bouri S/O Shital Bouri found that said Bimal Bouri liquor at his own Goomty and seeing the police party some person fled away and said Bimal Bouri to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Bimal Bouri (41 Yrs.) S/O Shital Bouri of Vill- Metyal Sahar PS- Adra Dist- Purulia and arrange for its investigation.
