Respected Sir,

In producing here with the arrested accused person namely Pradhan Bouri (35 Yrs approx), S/O- Lt. Rashu Bouri of Vill- Brindabanpur, P.O - Ramkanali, P.S - Santuri, Dist - Purulia along with seized Country Spirit bottles (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17.15 hrs I received a credible source information that one person namely Pradhan Bouri, S/O- Lt. Rashu Bouri of Vill- Brindabanpur, P.O - Ramkanali, P.S - Santuri, Dist - Purulia is stocking and selling Country Spirit without any valid license from his dwelling house at Brindabanpur village near Bouripara, P.S - Santuri, Dist - Purulia. Accordingly, I along with force had been to the spot for Brindabanpur to work out the source information and held raid into the premises of above mentioned accused person. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person is stocking Country Spirit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrest him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed Country Spirit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 12 (Twelve) liter Country Spirit has been seized, total value of the seized Country Spirit is Rs- 1300 (One thousand three hundred only).

Under the above circumstances and fact, I therefore pray that a cog. case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Pradhan Bouri, S/O- Lt. Rashu Bouri of Vill- Brindabanpur, P.O - Ramkanali, P.S - Santuri, Dist - Purulia and arrange for its investigation.
