Balarampur, Dist- Purnia to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of direct hooking from the nearby LT04 Line of WBSEDCL

Acting upon such information today on 10/04/2017 in between 1.35 PM to 2.00 PM I alongwith Sri Jitendra Kishore Mondal, AE, S&LP, Purnia Region office, Sri Samar Kr. Pandey (Retd. DSP), S.O Purnia Region office, Sri Anup Mondal SAE Balarampur CCC, Sri Dhajadhar Sarkar ACM Balarampur CCC and other staffs of WBSEDCL inspected the premises of Mahadeb Kumar (Majhi) and held raid.

During raid and inspection it was detected that the accused Sri Mahadeb Kumar (Majhi) is using electricity dishonestly by making direct hooking from the nearby LT04 Line of WBSEDCL for using

No notice was served to the accused as he is not our consumer and the premises have no electricity service connection.

I directed Sri Dhajadhar Sarkar, ACM to disconnect the hooking line from our LTOH line. Accordingly Sri Sarkar disconnected the aforesaid hooking line from LTOH line.

I prepared seizure list in presence of the accused and witnesses, details of seizure have been mentioned in the seizure list. Local people and the accused refused to sign on the seizure list.

The inspection team left the premises after completion of inspection at about 2:00 PM.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the abovementioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003, (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
