I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Ananda Kuiry, S/O- ~~st~~ late Rakhahary Kuiry of villege Sasa, P.O- Serengdi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 29.03.2017 at about 2-20 PM I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. J. R. Mandal, AE (E) S&LP 2. S. K. Pandey S.O. (Retd DSP) S&LP 3. Sri Shankar ch. Mahato entered the premises of Sri Ananda Kuiry S/O- lt. Rakhahary Kuiry of villege Sasa P.O- Serengdi, Dist- Purulia and found Sri Ananda Kuiry was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.674 KVA.
