Entered the premises of Pankaj Kr. Ghosh S.O- Lt. Anil Kr. Ghosh of Village- Lower Bendasol P.O- Adra P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by bypassing the service cable before energy meter and due to that reason a huge loss is facing by the department.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① Ceiling Fan = 10 nos of 80 watt each
- ② A.C. = 1 no of 1000 watt
- ③ Light = 10 nos of 20 watt each

Out of which we seized the following:

approx 2mts PVC cable with bypassing arrangement.

The seizure lists are prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 12:25 PM on dated 18.03.2017. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
