I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Bikash Singh Sarder, S/O-Prananath Singh Sarder, Vill- Tantan , PO- Madla, P S-Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1)/(a) of electricity act 2003 subsequently amendment act 2007.

On 17.01.2017 at about 4.15 p.m. I Sri Swapan Kumar Das, AE & Station Manager Bagmundi CCC along with Abdul Hasib L M, Bagmundi CCC entered the premises of Sri Bikash Singh Sarder, S/O- Prananath Singh Sarder, Vill- Tantan , PO- Madla, P S-Bagmundi Dist- Purulia and found Sri Sri Bikash Singh Sarder, was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.5 KVA. As Sri Bikash Singh Sarder, S/O- Prananath Singh Sarder, committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of Abdul Hasib LM Bagmundi CCC WBSEDCL. We left the premises at 04.25 p.m.


We seized PVC 2*1core Cable with Hooking Device-20 ft (approx).
