Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Alope Paramanik (35) S/O- Rampada Paramanik of Paharabera, PS-Neturia, District- Purulia with seized articles viz 1) One white plastic jerricane containing approx 20 lit. I/D liquor, 2) 07 sealed bottles of Dil Se country spirit containing 375 ml each, 3) 03 empty bottles of Dil Se country spirit, 4) 36 disposable plastic glass, 5) Rs. 155/- as sale proceed and do hereby lodge complaint against the above noted accused person to the effect that today (30.03.17) in between 18.35 hrs to 19.45 hrs. a raid was conducted in open cultivation land near Paharabera village, PS-Neturia, District- Purulia situated at Paharabera Mouza under Neturia PS, on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling ld. liquor in an open place, on demand Alope Paramanik failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and I arrested him U/S-67 BE Act and also seized 1) One white plastic jerricane containing approx 20 lit. I/D liquor, 2) 07 sealed bottles of Dil Se country spirit containing 375 ml each, 3) 03 empty bottles of Dil Se country spirit, 4) 36 disposable plastic glass, 5) Rs. 155/- as sale proceed under proper seizure list duly signed by witnesses as well as the accused person and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The above noted arrested accd. namely Alope Paramanik (35) S/O- Rampada Paramanik of Paharabera, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of ld. liquor.

It may note here that during raid 1. C /353 Baidyanath Mukherjee, 2. C/420 Sk. Chand both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Alope Paramanik (35) S/O- Rampada Paramanik of Paharabera, PS-Neturia, District- Purulia under proper section of law.
