

I do hereby submit complaint Suo-motto against (1) Mritunjoy Mondal S/O- Sri Binanda Mondal of Bartoria (2) Mohan Bouri S/O- Ghughur Bouri of Bartoria (3) Sanjoy Mondal S/O- Bablu Mondal of Bartoria (4) Nirmla @ Bappa Mondal S/O- Dilip Mondal of Bartoria (5) Sailen Mondal S/O- Sri Sunil Mondal of Bartoria (6) Biswanath Bouri S/O- Mitlen Bouri of Bartoria (7) Bablu Mondal S/O- Lt. Sunil Mondal of Bartoria (8) Jiten Maji S/O- Lt. Jagadish Maji of Bartoria (9) Kalipada Mondal S/O- Lt. Khepa Mondal of Bartoria and near about 100 other local-villagers including women and children, PS- Neturia to the effect that on receipt of information of Road blocked vide Neturia P.S GDE no- 1430 Dated. 31/03/17 at 08:45 hrs, myself along with SI, ASI and forces left PS for Bartoria under Neturia PS. After reaching there at about 09.00 hrs, I found that the Road near Bartoria which runs between Purulia and Barakar (SH-5), had been blocked by above noted persons and near about 100 others including women and children with water containers. They blocked the Pucca road on the issue of irregular supply of water by PHE in their village. They were raising slogans against Govt. & PHE. I have tried to pursue the agitator to withdraw the blockade and help police to disperse the mob as well as discharge lawful duty. It was also found more than 55/65 vehicles loaded with goods and loaded with passengers and drivers including patients etc. from Purulia Side and Barakar side were detained there and subjected to enormous sufferings for a long time i.e. 08:45 hrs to 09:30 hrs. The above accused persons continued to be with the unlawful assembly, causing unlawful restraint to the vehicles & passerby and thus generated danger & obstruction in state highway and also caused obstruction to police in discharging Govt. duty. After long 45 minutes discussion, they withdrew the blockade at about 09.30 hrs. On returning to P.S. I Start Neturia PS Case no- 32/17 Dt.- 31/03/17 U/S- 143/341/283/186 IPC, read with Sec. 18 of the West Bengal Highway Act 1964 against the above FIR named accd and near about 100 others.
