In producing here with one arrested accd namely Astik Kaibarta (27) S/O Gouranga Kaibarta of Vill- Beko (Kaibarta Para) PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 21 bottles (in sealed condition) DIL KHUSH 80 up country spirit, 600-ml each bottle and value-Rs-30 of each bottle.
- 2) Sale proceed of Rs.- 88/-
- 3) Ten pieces of plastic glass.

I ASI Giridhari Roy of Adra P.S. do here by lodged a complaint against accd. namely Astik Kaibarta (27) S/O Gouranga Kaibarta of Vill- Beko (Kaibarta Para) PS- Adra Dist- Purulia to the effect that today (21/03/17) at about 16:45 hrs. I received a telephonic information from a reliable source that one Astik Kaibarta (27) S/O Gouranga Kaibarta of Vill- Beko (Kaibarta Para) PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/ 124 Avijit Khan & JC/862 Ujjal Rajak rushed to the spot for raid by Govt. vehicle vide Adra PS GDE No. 1129 Dt. 21.03.17. At about 17:35 hrs. Myself along with force reached at Beko Village (Kaibarta Para) under Adra PS and hold raid in the Grocery Shop of Astik Kaibarta (27) S/O Gouranga Kaibarta found that said Astik Kaibarta liquor at his Grocery Shop and seeing the police party some person fled away and said Astik Kaibarta to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Astik Kaibarta (27) S/O Gouranga Kaibarta of Vill- Beko (Kaibarta Para) PS- Adra Dist- Purulia and arrange for its investigation.
