In producing herewith the accused persons namely Bikash Mandal (27 Years/Male) S/O Bhupen Mondal of Vill- Rabidih, PS- Baghmundi, Dist-Purulia and Gopal Mandal (34 Years/Male) S/O Rupsanatan Mandal of Vill- Chorida, PS- Baghmundi, Dist-Purulia along with seized articles 1) 60 (Sixty) ltrs (Chullu) ID Liquor containing in 06 (Six) Jarican 10 Liters each 2) 06 (six) Plastic glass 3) RS-/265 as sale proceed which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 02.04.17 during the special raid I along with 1. C/1405 Sital Ch. Karak, 2. C/462 Baidyanath Kumar, 3. HG-1607 Bimal Singh Sardar at 19.05 hrs arrived at Chorida village and a raid was conducted in the house of Gopal Mandal (34 Years/Male) S/O Rupsanatan Mandal of Vill- Chorida, PS- Baghmundi, Dist-Purulia, acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that one Bikash Mandal (27 Years/Male) S/O Bhupen Mondal of Vill- Rabidih, PS- Baghmundi, Dist-Purulia and Gopal Mandal (34 Years/Male) S/O Rupsanatan Mandal of Vill- Chorida, PS- Baghmundi, Dist-Purulia were conjointly keeping/ selling Id Liquor (Chullu) which were kept with their possession in Gopal Mandal's house. On demand they failed to produce any valid document from competent authority in respect of conjointly stocking & selling of liquor. As such they were arrested U/S- 67 B.E. Act. And also seized 1) 60 (Sixty) ltrs (Chullu) ID Liquor containing in 06 (Six) Jarican 10 Liters each 2) 06 (six) Plastic glass 3) RS-/265 as sale proceed which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. A sample ID liquor (Chullu) taken out as sample and all seized articles were labeled properly in presences of witness and accused persons. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the arrested person.

The arrested accused person namely, Bikash Mandal (27 Years/Male) S/O Bhupen Mondal of Vill- Rabidih, PS- Baghmundi, Dist-Purulia and Gopal Mandal (34 Years/Male) S/O Rupsanatan Mandal of Vill- Chorida, PS- Baghmundi, Dist-Purulia committed an offence U/S- 46 B.E. Act. 1909 for unauthorized possession and selling of Id Liquor (Chullu) from their sole possession in Gopal Mandal's house.

Under the fact and circumstances therefore pray a Case U/S- 46 (A) (c) B.E. Act. 1909 may kindly be started against the said accused persons namely Bikash Mandal (27 Years/Male) S/O Bhupen Mondal of Vill- Rabidih, PS- Baghmundi, Dist-Purulia and Gopal Mandal (34 Years/Male) S/O Rupsanatan Mandal of Vill- Chorida, PS- Baghmundi, Dist-Purulia.
