Sub: - F.I.R. against CHEPU BAURI, S/O- Late Dhuki Baurl of VILL-Haraktore , P.S.-Para, Dist Purulia against theft of electricity.

Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that *Chepu Bauri*, S/O- Late Dhuki Bauri of Village-Haraktore, P.S.-PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 25.04.2017 at about 1:45PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with MR Samar kumar Pandey, Retd DSP,(Spl. Officer)of Purulia Regional office, Mr Bilash Mahto Gr I TSH of Dubra Para CCC, Mr Shankar Chandra Mahto,L.M. of Purulia Regional Office, and Mr Dayamay Mahto,TSH WBSEDCL inspected the premises of Chepu Bauri, it was found that the said *Chepu Bauri* was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01 nos bulb and 01 no fan, approx load 0.120 KW for domestic Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 2:05 pm.

As such *Chepu Bauri* S/O₂ Late Dhuki Bauri of Village-Haraktore, P.S.- Para, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
