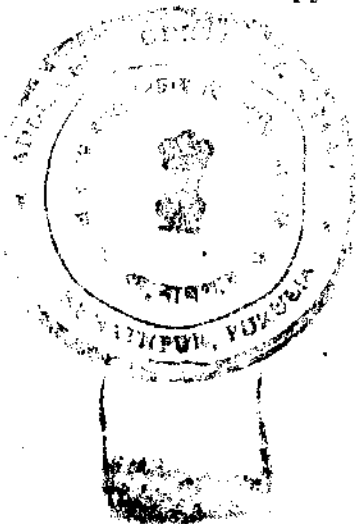

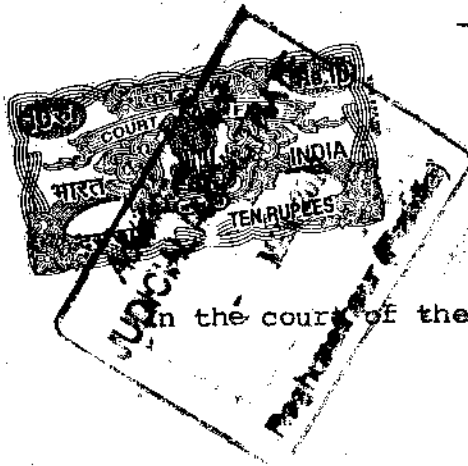

2. That on 11.01.2017 in night of 10.01.2017 at about
1 A.M., about 5/7 unknown miscreant armed with deadly

security guard in a office room under Threat showing
their deadly weapon. Then the miscreants braking the
door of store room, committed theft and took away
the various type of materials the pump shaft, Pump

cost of Rs. 14,00,000/- (Fourteen lakhs).
