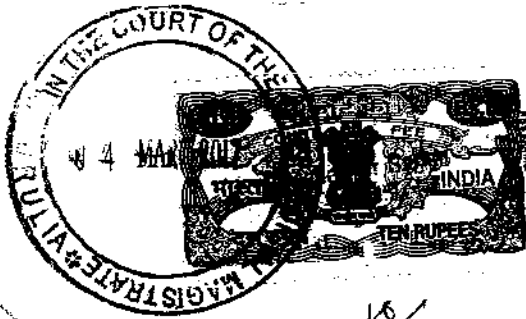

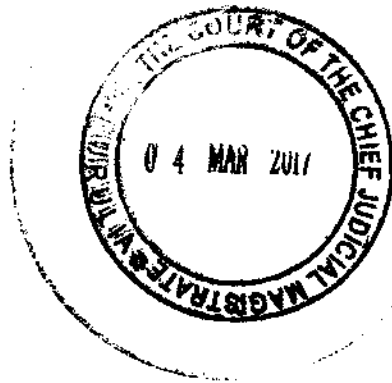

2) _____ That, the Complainant over cell phone contacted one Manik Mahato, her elder brother-in-law's son, who apprised her that her minor son Bhabes @ Suman Mahato was missing, Said Manik Mahato and her other relatives advised the complainant for returning back to her Village - Tumba-Jhalda and pursuant to such advise the Complainant returned back to her house at Tumba-Jhalda at about 10 A.M. and thereafter she along with her relatives visited Arsha P.S. for lodging information towards the missing of her son.

3) _____ That, during her stay at Arsha P.S. one Kunal Mahato son of *Janit Kumar Mahato*, resident of Vill.- Hulka, P.O. *Chakra*, P.S.- Purulia(M), and Dist.- Purulia, who happens to be the friend of said Bhabes @ Suman Mahato ^{made} her son-in-law viz. Badal @ Chandra Mahato son of Late Anil Mahato of Vill.- Barkitarh, P.O.- Karmatarh, P.S.- Joypur, Dist.- Purulia aware over mobile phone that said Bhabes @ Suman Mahato has been given in marriage with one Samal Mahato daughter of Chepu Mahato of same Village by using force by said Shyamal Hazra and some of his co-villagers namely - Dileswar Mahato son of Barani

5) _____ That, taking the advantage of the Complainants temporary absence the accused persons abducted her minor son namely Suman Mahato @ Shabir Mahato from their house within Arsha P.S. and from his lawful Guardianship namely ~~Suman Mahato @ Bhabes Mahato~~ have given him in marriage forcefully and now kept him secretly and wrongfully to confine him and thereby committed crimes/offences for which they ought to be prosecuted and punished. All of these accused persons are committed offence by way of taking part in the child marriage, directing the same most illegally and the father of said Samala was/is every much concerned with the said marriage which is also a Crime.

6) _____ That, the Complainant requested the Police personnel to receive the letter of Complaint so prepared depicting interalia all the real facts so taken place, but suprisingly enough the P.S. concerned refused even to take the Written Complaint.

7) _____ That, due to such inaction on the part of the Police personnel of concerned P.S. the accused persons were rather encouraged in performing their acts in utter violation of law. Still they are abusing the

8) _____ That, your Petitioner then informed the matter

to incur the expenses of a Complaint Case, more over,
search and seizure is very much required.
