- 1) Fifteen (15) sealed glass bottles (CS) containing 600 ml each and labelled with DILSKHUSH.
- 2) Eight(08) sealed plastic bottles (CS) containing 375 ml each and labelled with DILSE.
- 3) Cash Rs-245/-(two hundred & fourty five only).
- 4) One yellow nylon bag.
- 5) One white big polythin bag.

ISI Arup Kr Chel of Arsha PS do hereby lodge this complaint regarding that today 21.03.17 at about 17.35 hrs during my evening mobile duty received source information over telephone that the above noted accused has been selling illegally and clandestinely infront of Tea shop at Kourang village beside Purulia-Tata main road and a Hanuman Mandir under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/186-Ramnath Mahato of Arsha PS, C/563-Tapas Mal,C/250-Ananda Rana both of SAP 7<sup>th</sup> Bn camp at Arsha PS rushed to the spot to work out the information. On arriving to the spot I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Ajit Paramanik(42), s/o-Lt Biswanath Paramanik @ Biswarup of vill-Kourang, PO-Puyara PS-Arsha, Dist-Purulia after preparing proper memo of arrest.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
