Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accused person namely Ranjit Bouri (51) S/O- Lt. Sukdeb Bouri of village Goaladih, PS-Neturia, District-Purulia with seizure of (1) 26 pcs. Sealed bottles of Dil Se country spirit containing 375 ml each, (2) 06 Pcs. Sealed bottles of Captain country spirit containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (18.04.17) in between 20.15 hrs to 21.45 hrs. a raid was conducted in the house of Ranjit Bouri (51) S/O- Lt. Sukdeb Bouri of village Goaladih, PS-Neturia, District- Purulia situated at Mouza Goaladih under PS Neturia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Ranjit Bouri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s $46 \, \Lambda(c)$ B.E. Act and he was arrested U/S-67 BE Act and also (1) 26 pcs. Sealed bottles of Dil Se country spirit containing 375 ml each, (2) 06 Pcs. Sealed bottles of Captain country spirit containing 600 ml each seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accused namely Ranjit Bouri (51) S/O- Lt. Sukdeb Bouri of village Goaladih, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/207 Dilip Kumar Paul & 2. C/932 Samiran Dey both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Ranjit Bouri (51) S/O- Lt. Sukdeb Bouri of village Goaladih, PS-Neturia, District-Purulia under proper section of law.
