## To The Officer in Charge Adra Police Station Purulia

Sir

In producing here with one arrested accd namely Muktar Ali @ Bhonda (55 Yrs) S/O Lt. Md. Suban of Joity More PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 22 bottles (in sealed condition) DILSE 80 up country spirit, 600-ml each bottle and value-Rs-26 of each bottle.
- 2) Sale proceed of Rs.- 132/-
- 3) Nine pieces of plastic glass.

I SI Supratik Mondal of Adra P.S. do here by lodged a complaint against accd. namely Muktar Ali @ Bhonda (55 Yrs) S/O Lt. Md. Suban of Joity More PS- Adra Dist- Purulia to the effect that today (07.01.2017) at about 18:05 hrs in course of my anti crime mobile duty I received a telephonic information from a reliable source that one Muktar Ali @ Bhonda (55 Yrs) S/O Lt. Md. Suban of Joity More PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/219 Dasharat Hazari & JC/124 Avijit Khan rushed to the spot for raid by Govt vehicle. At about 18:45 hrs myself along with force reached at Joity More and hold raid in the Jhupri of Muktar Ali @ Bhonda and found that said Muktar Ali @ Bhonda selling liquor at his own shop and seeing the police party some person fled away and said Muktar Ali @ Bhonda tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid license or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Muktar Ali @ Bhonda (55 Yrs) S/O Lt. Md. Suban of Joity More PS- Adra Dist-Purulia and arrange for its investigation.
