In producing herewith one accused person namely Parsu Ram Majhi@ Mandi(28), s/o-Bhandu Majhi @ Mandi of vill-Nunia, PS-Arsha, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Fourteen (14) sealed glass bottles (CS) containing 600 ml each and labelled with DILSKHUSH.
- 2) Six(06) sealed plastic bottles (CS) containing 375 ml each and labelled with DILSE.
- 3) Cash Rs-235/- (two hundred & fourty five only).
- 4) One yellow nylon bag.
- 5) One white big polythin bag.

I SI Arup Kr Chel of Arsha PS do hereby lodge this complaint regarding that today 25.03.17 at about 21.05 hrs during my evening mobile duty received source information over telephone that the above noted accused has been selling illegally and clandestinely at Sirkabad Bus stand under a Chhatim tree under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/538-Eshan Prosad Baskey, C/604-Mirza Nurul Isiam both of SAP 7<sup>th</sup> Bn camp at Arsha PS rushed to the spot to work out the information. On arriving to the spot at 21.25 I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Parsu Ram Majhi@ Mandi(28), s/o-Bhandu Majhi @ Mandi of vill-Nunia, PS-Arsha, Dist-Purulia after preparing proper memo of arrest.
