

- 4) One yellow nylon bag.
- 5) One white big polythin bag.

On arriving to the spot at 21.25 I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. 
