As subjected, this is to inform you that we (PKTCL) had cut forest trees after getting appropriate working permission from the DFO, Purulia Office. We were establishing 400 KV D/C Transmission Line from Sonelia (Baghmudi) to Ranchi as per Ministry of Power, Govt. of India guidelines.

The felled were not allowed to be transported by the local villagers. After sometime, ^{on dated 24/3/17} taken we visited the locations we found that nearly all tree (felled) had vanished and were gradually stolen by the local villagers.

Thus requesting you to kindly do the FIR against unknown people for the theft of the felled trees.
