400 kv D/c Transmission Line from Purulia (Baghmundi)  
to Ranchi as per Ministry of Power, Gov. of India  
guidelines.

The felled were not allowed to transported by the  
local villagers. After sometime <sup>on dated 24/3/17</sup> when we visited the location  
we found that nearly all tree (felled) had vanished  
and were gradually stolen by the local villagers.

Thus requesting you to kindly do the FIR  
against unknown people for the theft of the felled trees.
