- 5) One white big polythin bag.

I PSI Sanjay Diger of Arsha PS do hereby lodge this complaint regarding that today 02.04.17 at about 19.35 hrs during my spl evening mobile duty received source information over telephone that the above noted accused has been selling illegal liquor illegally and clandestinely infront of his Pokora shop at Mishirdih more village-Mishirdih on Arsha Tamna main road under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/688-Sk Sahid,C/645-Bhaskar Biswas both of SAP 7th Bn camp at Arsha PS rushed to the spot to work out the information. On arriving to the spot at 20.15 I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure list and labelled the seized articles duly signed by the accompanying party in the seizure list and the label.
