I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Panchanan Pandey S/O- Shri Nitin Niranjan Pandey of village Nandaramdih, P.O- Kalimati, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 24.04.2017 at about 4.30 PM I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Samarkr. Pandey Rtd. DSP (S.O Puruliya office) WBSEDCL 2. Sri Sukhamoy Maji SAE 3. Sri Dayamoy Mahato TSH entered the premises of Sri Panchanan Pandey, S/O- Shri Nitin Niranjan Pandey of village Nandaramdih, P.O- Kalimati, Dist- Purulia and found Sri Panchanan Pandey was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Panchanan Pandey S/O- Shri Nitin Niranjan Pandey committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji SAE 2. Sri Dayamoy Mahato TSH. The inspection team left the premises at 4.45 PM 24.04.2017.
