





The above named complainant begs to state as follows:-

Most respectfully begs to state:-

- That the complainant is a resident of village + P.O- Tunturi, P.S- Baghmundi, Dist-Purulia, and within the jurisdiction of this Ld. Court.
- 2. That Satyendra Kuiry since deceased was the son of your petitioner.
- 3. That the son of the complainant viz Satyendra Kuiry got married in the year of 2010 with one Pushpa Devi, D/o- Tarani Kuiry, of Village- Budanguru, P.S- Baghmundi, Dist- Purulia i.e the accused No. 2, and out of the wedlock she gave birth of two children.
- 4. That soon after the marriage of the son of the complainant with Pushpa Devi, she fall in love with one namely Ram Nath Kuiry, S/o- Hablu Kuiry, a resident of village + P.O- Tunturi, P.S- Baghmundi, Dist- Purulia, i.e the accused No. 2 and there was an illicit relationship between the accused No. 1 and 2.
- 5. That having came to learn about the illicit relationship in between the accused persons the son of the complainant namely Satyendra Kuiry protested the same and








requested the accused No. 2, not to continue such type of illicit relationship with the accused No. 1, but hearing this the accused No. 2 suddenly became violent and abused the son of the complainant in filthy languages.

- 6. That on 20.10.2015, both the accused persons were caught red handed in the bed in a compromise condition and seeing the complainant and others the accused No. 1 somehow managed to escape from the place leaving his 'Chappal' outside the room.
- 7. That thereafter the matter was reported to the father of the accused No. 2, but the reason is best known to him, instead of take up the matter some persons Viz 1. Tarani Kuiry, S/o-, Hari Kuiry, 2. Raju Kuiry, S/o- Ghosal Kuiry, both are resident of Burangoru, P.S- Baghmundi, Dist- Purulia, 3. Dilip Kuiry, S/o- Basanta Kuiry, a resident of Vill- Koradih, P.S-0 Jhalda, Dist- Purulia, alongwith the accused No.1 came to the house of the complainant on 25.10.2015, and started to abuse the son of the complainant in filthy languages in presence of the accused No. 2 and they threatened the son of the complainant namely Satyendra Kuiry in dire consequences and directed him not to disclosed about the illicit relationship of the accused persons to anybody, failing which he will be murdered and thereafter fled away.
- 8. That after the incident the accused No. 2 became more furious and adamant and continued their relationship with more boldness.
- 9. That on 09.11.2015 at about 2 A.M, the accused No. 2 informed the complainant over mobile phone that his son has committed suicide in the northern side of the village in palash jungle in a neem tree by hanging.
- 10. That hearing this the complainant and some others rushed to the spot and after searching the accused No. 2 showed the dead body of the deceased namely Satyendra Kuiry and thereafter on 10.11.2015, an information was lodged before the I/C Suisa outpost and police arrive at the spot and send the dead body for post mortem.
- 11. That from the circumstances set forth above it is crystal clear that the accused persons in collusion with others by hatching a criminal conspiracy, with common intention





and object murdered and / or abetted to commit suicide to Satyendra Kuiry and thereby committed the various offences punishable under Indian Penal Code.

- 12. That your petitioner informed the matter to the local Police Station as well as to the S.P. Purulia, and various other authorities, but no action has been taken by them. The reason is best known to them.
- 13. The Xerox copy of the information given to the various authority is enclosed herewith.
- 14. That the matter is required to be investigated by C.I.D to unearth the truth and the wrongdoers. Your petitioner also learnt that some muscle power persons threatened to the local people not to give evidence failing which they have to face the consequence. Hearing this the witnesses are frightened, hence for the ends of justice the investigation by the C.I.D is not only required but also demanded.
- That the accused persons have committed an offence U/s- 302/306/120B/109/34 of the I.P.C. and other offences.

It is therefore prayed that your Honour will be graciously pleased to send this petition to O/C Baghmundi P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to start a case and to hand over the matter to the C.I.D for investigation of the case in accordance with law and to unearth the wrong doers so that they can face their trial in the court of law.
