Sub- Illegal mining operations within mine boundary

Dear Sir,

Pit Safety Committee members of Parbelia colliery, led by the Safety Officer, inspected the surface conditions in the vicinity of Parbelia village, in the N-E portion of the mine, on 26.04.2017. This inspection is a regular safety aspect of a mine, to ascertain its monsoon preparedness. In the course of their inspection the members found that there were 08 nos. of freshly excavated and 09 nos. of brick lined; illegal pits in the area. The pits were being actively worked and in various stages of completion.

Please be informed that the illegal pits in the said area were duly filled up with the help of the State Administration and Sodepur Area Officials; during the period of 13.3.2017 to 24.03.2017.

The continuation of the present illegal operations on the rise side of the mine property will certainly lead to inundation of the mine, as they are connected to the mine workings. This is a serious threat to the safety of the mine and the miners.

Considering the gravity of the situation, please consider this letter as an FIR against unknown persons and do the needful to enable us to continue with our mining operations.
