Sir,

In producing herewith one 407 Van bearing No. WB55/2475 loaded with stolen steam coal approx 06 MTs with proper seizure list. Fact of the case in brief is that on 23.01.17 at about 20:45 hrs myself along with force C/823 Swapan Kr. Barik and C/157 Dipak Bouri were on evening mobile duty on Raghunathpur - Saltora road and received a source information that the above noted vehicle is coming loaded with steam coal from Murulia side towards Sadhusaltora. After receiving this information we had been to Raghunathpur - Saltora road near Sadhusaltora morh and placed Naka Checking with a view to intercepted said vehicle. At 21:25 hrs we found that the above noted vehicle is coming from Bidhakata side. Seeing police, the driver of the said vehicle attempted to flee away but on being chased the driver stopped the vehicle on road and fled away the driver in the dark side. I searched the vehicle and found that about 06 (Six) MTs steam coal loaded in this vehicle and the key of the vehicle has been left away by the driver. Made several attempts to find out the driver but failed to trace him out. No public witness was available there. It is reasonable to believe that driver and owner of the said vehicle collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains and habitual to run this business. So the driver and owner of the said vehicle are liable for punishable offence U/S 379/411/413/414 IPC, I seized the said vehicle loaded with 06 (Six) MTs steam coal under proper seizure list.

I therefore pray that kindly start a case against driver and owner of the said vehicles and other as per law and arrange its investigation.
