




# The above name complainant begs to state as follows:

- 1) That the complainant as well as the accused person are the permanent resident of village- village- Kalimati, P.S. Bagmundi, Dist-Purulia and both the parties residing side by side accordingly the accused persons on the plea that flow of water from the house of the complainant scattered in kuli road and for that the accused persons abused the complainant and his family members in filthy languages which happens seven days prior to the date of incident and they have enunity with regard to the said issue.
  - 2) That on the date of incident i.e. on 28/10/2016 at about 9:00 -9:30 PM when the complainant and his family members were in their house at that time all the accused persons armed with lathi, tangi etc., criminally trespassed in the house of the complainant by breaking the opened the outer door causing loss of Rs. 5,000/- entered in the house of the complainant and abused the in filthy languages then the complainant and his inmates tried to convince the accused persons in all possible manner.



- That in course of altercation the accused persons assaulted the complainant and when the female members are trying to rescue the complainant then the above noted accused with criminal intention outraged the modesty of Smt.

  Shart Blagat.
- That the complainant and his family members reported the incident to the local people including the witness all of them show the incident then the accused persons left the place and that they have taken some house hold articles namely one pitcher made of brass and two bucket made of pital the value of those articles is about Rs. 10,000/- and also damaged other house hold articles.
- 5) That the accused persons also threatened that if the complainant date of lodged any complaint against them in that case they would put fire in to his dwelling house so that the complainant and his family members compelled to left the village they also threatened by giving out that they would lodged several false complaint against them.

That the very next morning the complainant thereafter 6) lodged one complaint to the local P.S. in writing and when no legal action was taken by the said Police then another complaint was lodged to the Superintendent of Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.
