P.S- Adra, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 16.01.2017 at about 2:50 PM, Sri Anirban Pal, Station Manager, Adra Customer Care Centre, WBSEDCL along with,

Entered the premises of Sundarlal Rajbansi, S.O- Lt. Munsilal Rajbansi of Village- Panehudanga, Napit Para, P.O- Adra, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by hooking from the nearest LT line.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e. one Fan, one TV, Four Lamp (100 W).

Out of which we seized the following:

- ① one incandiscent Lamp of 100 W.
- ② 5 MTR GI wire with 3 MTR PVC cable with hooking device.

The seizure lists are prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 3:00 PM on dated 16.01.2017. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.
