Chowdhury has enjoyed Electricity unauthorisedly by bypass of meter through service cable tapper & due to this reason he has committed theft of electricity U/S 135 of The Electricity (amendment) Act-2007.

Entered the premises of Rabindranath Chowdhury, vill - Bindabampur, P.S - Santuri, Consumer I.D. NO - 242062246, Meter NO - L214808

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by taping the incoming cable of the energy meter installed in the said premises and therefore bypassing the energy meter of W.B.S.F.D.C.L. i.e. U/S 135 (1) (b) was detected.

From the above arrangement he/she was using the following electrical equipments

- 1) Water pump - 1 NO - 746 W,
- 2) Celling Fan - 1 NO - 60 W,
- 3) Bulb - 2 Nos - 200 W.
