Entered the premises of Biswanath Ghosh, S.O- Lt Pradyut Kr Ghosh of
Village- Kantarajuni, P.O- Adra, P.S- Adra, Dist-Purulia and
inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly
by drawing illegal bypassing from incoming
service cable before Energy meter

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) Pump = 7 No's = 746 watt
- 2) Fan = 6 No's = 360 watt
- 3) Washing Machine = 1100 watt
- 4) Fridge = 250 watt
- 5) Light = 120 watt
- 6) TV = 60 watt

Out of which we seized the following:

Some portion of service cable (white) and bypass
arrangement before energy meter (approx 1 meter cable and 300 mm
wire)

The seizure list is prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 04:25 PM on dated 19/07/2019. The
accused person has committed an offence U/S-135(i)(B) of the Electricity (Amendment) Act-2007.
