Sir,

In producing herewith 03 (Three) accused persons namely 1. Sukdeb Mura (35 Yrs), S/O- Lt. Lakhu Mura, 2. Bishya Sing Mura (48 Yrs), S/O- Lt. Lakhu Sing Mura and 3. Prahalad Sing Mura (65 Yrs), S/O- Lt. Baghu Sing Mura all of vill- Bara Dava, PS-Baghmundi, Dist-Purulia to the effect that on 07/06/2020 at about 11:15 hrs while I SI Sudhir Kumar Mahato along with force C/673 Pintu Gorain, C/773 Sudarshan Majhi both of SAP 11th Bn. Camp at Baghmundi PS and JC/549 Arun Kumar Duley of Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No- 294, Dated- 07/06/2020. During my mobile duty when myself along with force reached at Charida More and found three persons were roaming aimlessly at Charida More on Baghmundi- Jhalda main road without mask or its alternative. I detained them. On being asked the above accused persons disclosed their identity as above but could not able to give any satisfactory answer for that movement on road and public place. Though unlock-1 is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 03/06/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is going on till now. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.


