In producing herewith two accused person namely 1) Gunu Ruidas (45 yrs) S/O- Lt. Mahi Ruidas of Vill- Kerowa, P.S- Balarampur, Dist.- Purulia, 2) Jagadish Paramanik (30 yrs) S/O- Lt. Pannalal Paramanik of Vill.-Karma, P.S- Balarampur, Dist.- Purulia along with eight (08) seized Motorcycles as per seizure list. I. S.I Satrughna Mahato of Balarampur P.S. beg to state that today i.e. on 18.06.2020 at about 17:25 hrs while myself along with 1) C/1232 Manik Chand Khanna, 2) C/841 Chanchal Paramanik, 3) JC/1205 Tapan Kr. Maity, 4) JC/1016 Parimal Tudu (vide Balarampur GDE No- 765 date 18.06.2020 & C.C. No- 2552/2020 date 18.06.2020) were engaged in NAKA Checking duty at Dava bridge under Balarampur P.S, I stopped & checked one Black Colour "HERO SPLENDER +" Motorcycle having registration No- JH05BP/0279, in which above noted two person were boarded & I asked to provide valid paper in respect of above noted Motorcycle but no sooner I had asked for the papers than they both started stammering that led to suspicion. Further, I asked for the papers regarding ownership but neither they could provide any paper related to the Motorcycle nor could give any satisfactory reply pertinent to the Motorcycle. On further interrogation, they confessed that they have stolen that bike & taken it to Balarampur for selling as they used to do it. Further they also revealed that they along with one Makar Ruidas S/O- Julu Ruidas of Vill.- Kerowa under Balarampur P.S area & some others are habitually dealing in stolen property since last few years.

Accordingly I seized the aforesaid Motorcycle having Reg. No- JH05BP/0279, Engine No- HA10ERGHJ83967, Chassis No- MBLHA10CGGHK70062 under proper seizure list duly signed by accused person & accompanied Police Personnel.

The aforesaid two accused person also stated that they have accumulated seven more stolen motorcycles at their house. Leading to their information, I went to Kerowa Village under Balarampur P.S & recovered four Motorcycles from the house of Gunu Ruidas. I seized the following Motorcycles after preparing seizure List duly signed by the accused person & Police personnel.

- 1) One Blue Colour Hero Honda Splender Motorcycle having Reg. No- JH10B/8693, Chassis No- 02G20F25973, Engine No- 02G18E25357
- 2) One Black Colour Passion Pro Motorcycle having Reg. No- JH01AW/1421, Chassis No- MBLHA10AWDGB04008, Engine No- HA10ENDGB04702.

- 3) One Red Colour Hero Honda Super Splender having Reg. No- WB38L/4307, Chassis No- 06GACE08075, Engine No- O6GACA08206.
- 4) One Black Colour Hero Honda Splender having Reg. No- WB02/7877, Chassis No- 95J17E04491, Engine No- Tempered.

Thereafter, I also went to village Karma under Balarampur P.S & recovered three motorcycles from the house of Jagadish Paramanik. Seized the following Motorcycles after preparing seizure list duly signed by the accused person & Police personnel.

- 1) One Black Colour Passion Pro motorcycle having Reg. No- JH05K/0260, Chassis No-MBLHA10AWDHG79922, Engine No- Tempered.
- 2) One Black Colour Hero Honda CD Delux motorcycle having Reg. No- JH05AXE/7527, Chassis No- MBLHA11ERA9E10777, Engine No- HA11EDA9E13080.
- 3) One Black Colour Passion Pro motorcycle without number plate, Chassis No- MBLHA10EWBHH34731, Engine No- HA10EDBHH36187
