In producing herewith arrested accused person namely Nagen Singh (45yer) S/o- Lt- Motilal Singh of vill- Mourang P.O Jitan, PS- Bandwan Dist- Purulia along seized article. I beg to report that on 21.01.2017 in course of my Special raid duty myself along with force got reliable source information that one person is selling illicit liquor at the house of said accused person under Bandwan PS. To work out the information we reached at village Mourangat 17:50 hrs and search the house and found that the said accused person was selling illicit liquor in his house. After seeing Police party, liquor customers fled away from the spot. On demand he failed to produce any valid documents for selling illicit liquor in his possession. So the above noted accused has committed an offence u/s- 46(A) (C) Act 1609. Amended up-to date accordingly. I arrested the above noted accused person u/s- 67 Bengal Excise Act. 1909 issued arrest memo and inspection memo. During search found approx 10(Ten) Itr illicit liquor containing in a white plastic container as asle proceed seized the above noted article under proper seizure list duly signed by the witnesses in between 18:05 hrs. to 18:25 hrs. I also seized and labeled the plastic container with sample illicit liquor at the spot in presence of accused person and witnesses and duly singed by them. I arrested him after informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S after getting permission from you I put him P.S lock up after maintaining all hazat rules as per law and informed duty officer and sentry duty accordingly with seized article.

Therefore I pray before you that Kindly arrange to start a specific case under proper section of law against arrested accused Nagen Singh (45yer) S/o- Lt- Motilal Singh of Mourang P.O Jitan, PS- Bandwan Dist- Purulia
