RespectePd Sir,

In producing here with arrested one accused person namely Bistu Gorai (26 yrs.) S/O Lt. Ranjit Gorai , Vill.- Gangamanna , P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized article is mentioned in attached seizure list). I beg to submit that today during Spl. Drive Raid duty at about 14.35 hrs I received a credible source information that one person namely Bistu Gorai (26 yrs.) S/O Lt. Ranjit Gorai , Vill.- Gangamanna , P.S. Bandwan, Dist. Purulia is selling Illicit liquor in his house under Bandwan PS this refers to Bandwan P.S. GDE No. 959 Dtd: 26.02.17. Accordingly, I along with force left for Gangamanna Village to work out the said source information. Then, at about 15:05 hrs we reached at Gangamanna Village and found the above noted person was selling Illicit Liquor at his house . So with the help of accompany force I searched thoroughly with proper decency and found that he is selling illicit liquor . Accordingly, I seized illicit liquor approx 12 (twelve) liter in a yellow plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 12 liter illicit liquor has been seized. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances , I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Bistu Gorai (26 yrs.) S/O Lt. Ranjit Gorai , Vill.- Gangamanna , P.S. Bandwan, Dist. Purulia and arrange for its investigation.
