Respected Sir,

In producing here with arrested accused person namely Buddheswar Mandi (32) S/O Lt. Rabi Mandi of vill. Ghatiuli, P.O. Lata, P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:25 hrs during my Spl. mobile duty I received a credible source information over mobile that one person namely Buddheswar Mandi (32) S/O Lt. Rabi Mandi of vill. Ghatiuli, P.O. Lata, P.S. Bandwan, Dist. Purulia making & selling illicit liquor in his house under Bandwan PS, this refers to Bandwan P.S. GDE No.222, Dtd. 06.03.17. Accordingly, I along with officers & force namely ASI (UB)Sanjay Ghosh, ASI (UB) Jashusri Bhattacharya both of Bandwan PS, ASI (AB) Sintu Sarkar (SAP 13th BN. Barjora, Bankura, Camp at Bandwan PS), C/1256 Anadi Dhibar, C/905 Sandip Dey & C/113 Sanatan Sing Sardar (both of SAP 13th BN. Barjora, Bankura, Camp at Bandwan PS) & VP Brihaspati Das, left for Ghatiuli Village to work out the said source information. Then, at about 17:45 hrs I reached at Ghatiuli Village and found the said person was selling Illicit Liquor at his house under Bandwan PS. So, with the help of accompany force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized illicit liquor approx 25 (twenty five) liters in a white plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 25 liters illicit liquor has been seized.

Under the above circumstances , I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Buddheswar Mandi (32) S/O Lt. Rabi Mandi of vill. Ghatiuli, P.O. Lata, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
