Respected Sir,

In producing here with arrested accused person namely Madan Mandi (59 yrs) S/O Lt. Buddheswar Mandi of vill. Chirugora, P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 13:50 hrs received a credible source information over telephone of table duty officer namely PSI Sk. Afiruddin that one person namely Madan Mandi (59 yrs) S/O Lt. Buddheswar Mandi of vill. Chirugora, P.S. Bandwan, Dist. Purulia making & selling illicit liquor in his house under Bandwan PS, this refers to Bandwan P.S. GDE No.734, Dtd. 21.03.17. Accordingly, duty officer inform to O/C Bandwan PS and direction me to work out the said information. I along with officers & force namely PSI Subrata Sarkar, C/1260 Santosh Soren, C/768 Ajit Kr. Murmu and JC/462 Prahallad Mahato all are Bandwan PS left for Chirugora Village to work out the said source information. Then, at about 14:45 hrs I reached at Chirugora Village and found the said person was selling Illicit Liquor at his house under Bandwan PS. So, with the help of accompany officer & force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized illicit liquor approx 21 (twenty one) liters in a black plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 21 liters illicit liquor has been seized.

Under the above circumstances , I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Madan Mandi (59 yrs) S/O Lt. Buddheswar Mandi of vill. Chirugora, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
