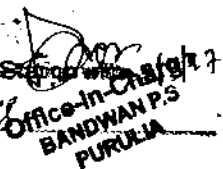

Respected Sir,

In producing here with arrested accused person namely Balahari Kisku (62 yrs) S/O Lt. Ananda Kisku of vill. Karakata, P.O. Dhadka, P.S. Bandwan, Dist. Purulia along with seized Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that about 15:45 hrs during my Spl. mobile duty I received a credible source information over mobile one person namely Balahari Kisku (62 yrs) S/O Lt. Ananda Kisku of vill. Karakata, P.O. Dhadka, P.S. Bandwan, Dist. Purulia making & selling illicit liquor in his house under Bandwan P.S. refers to Bandwan P.S. GDE No.785, Dtd. 22.03.17. Accordingly, I along with officers & force namely ASI (UB) Sanjay Ghosh, ASI (UB) Jashusri Bhattacharya both of Bandwan PS C/113 Sanata Sardar of SAP 13th BN. Barjora, Bankura, JC/462 Prahalad Mahato of Bandwan PS, Karakata Village to work out the said source information. Then, at about 16:15 hrs I reached Karakata Village and found the said person was selling illicit liquor at his house under Bandwan P.S. So, with the help of accompany force I searched thoroughly with proper decency and maintained all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one of them. Then, I seized illicit liquor approx 28 (twenty eight) liters in a black plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 28 liters illicit liquor has been seized.

Under the above circumstances , I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Balahari Kisku (62 yrs) S/O Lt. Ananda Kisku of vill. Karakata, P.O. Dhadka, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
