Respected Sir,

In producing herewith the arrested accused person namely Sanatan Tudu (52 yrs) S/O Lt. Sraban Tudu of vill. Bhomragora, P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 15:20 hrs in course of my Spl. raid duty myself along with force got a reliable source information over my mobile phone that one person namely Sanatan Tudu (52 yrs) S/O Lt. Sraban Tudu of vill. Bhomragora, P.S. Bandwan, Dist. Purulia is selling illicit liquor in his house under Bandwan PS. Accordingly, I along with officers & force namely ASI Sanjay Ghosh, C/1260 Santosh Soren, JC/781 Somnath Dutta all are Bandwan PS, C/905 Sandip Kr. Dey of SAP 13<sup>th</sup> BN, Barjora, Bankura camp at Bandwan PS left for Bhomragora Village to work out the said source information. Then, at about 15:55 hrs I reached at Bhomragora Village and found the said person was selling Illicit Liquor at his house under Bandwan PS. So, with the help of accompany officer & force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized illicit liquor approx 11 (eleven) liters in a white plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 11 liters (approx) illicit liquor has been seized.

Under the above circumstances , I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Sanatan Tudu (52 yrs) S/O Lt. Sraban Tudu of vill. Bhomragora, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
