Respected Sir,

In producing here with arrested accused person namely Lusaram Murmu (37 yrs) S/O Lt. Chunaram Murmu of Vill. Madhuban, P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 14:45 hrs received a credible source information over telephone of table duty officer namely SI Arun Kr. Bose that one person namely Lusaram Murmu (37 yrs) S/O Lt. Chunaram Murmu of Vill. Madhuban, P.S. Bandwan, Dist. Purulia selling illicit liquor in his house under Bandwan PS, this refers to Bandwan P.S. GDE No.59, Dtd. 02.04.17. Accordingly, duty officer inform to O/C Bandwan PS and direction me to work out the said information. I along with officers & force namely ASI Jashusri Bhattacharya, ASI Sanjay Ghosh and JC/679 Mithun Ruhidas, JC/462 Prahallad Mahato all are Bandwan PS left for Madhuban Village to work out the said source information. Then, at about 15:45 hrs I reached at Madhuban Village and found the said person was selling Illicit Liquor at his house under Bandwan PS. So, with the help of accompany officer & force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized illicit liquor approx 21 (twenty one) liters in a white plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 21 liters illicit liquor has been seized.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Lusaram Murmu (37 yrs) S/O Lt. Chunaram Murmu of Vill. Madhuban, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
