Respected Sir,

In producing here with arrested accused person namely Birjupada Murmu (52 yrs) S/O Lt. Parameswar Murmu of vill. Cheradungri, P.S. Bandwan, Dist. Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:25 hrs during my Spl. mobile duty I received a credible source information over mobile that one person namely Birjupada Murmu (52 yrs) S/O Lt. Parameswar Murmu of vill. Cheradungri, P.S. Bandwan, Dist. Purulia selling illicit liquor in his village under Bandwan PS, this refers to Bandwan P.S. GDE No.827, Dtd. 22.04.17. Accordingly, duty officer inform to O/C Bandwan PS and direction me to work out the said information. I along with officers & force namely ASI Jashushri Bhattacharya, JC/1055 Ujjwal Das Chakraborty, JC/1233 Tapash Mondal all are Bandwan PS left for Cheradungri village to work out the said source information. Then, at about 18:50 hrs I reached at Cheradungri village and found the said person was selling Illicit Liquor in his village under Bandwan PS. So, with the help of accompany officer & force I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him & maintain all formalities regarding arrest. Then, I seized illicit liquor approx 15 (fifteen) liters in a blue plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 15 liters illicit liquor has been seized.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Birjupada Murmu (52 yrs) S/O Lt. Parameswar Murmu of vill. Cheradungri, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
